

Minutes of the Cherokee County Board of Education Meeting held February 9,
2017 beginning at 6 pm at Central Office

Board Members Present

Ms. Wanda Arrowood, Chair, Mr. Paul Brown, Vice Chair, Mr. Winfield Clonts, Mr. Tim Coffey, Mr. Jeff Tatham, and Mr. Tim West

1. **Call to Order.** Ms. Wanda Arrowood called the Board of Education meeting to order.
2. **Pledge of Allegiance.** Mr. Winfield Clonts led the Pledge of Allegiance.
3. **Mission Statement.** Mr. Tim Coffey read the mission statement.
4. **Approval of Agenda.** The agenda was accepted as presented.
5. **Approval of Minutes.** The Minutes of the January 12, 2017 board meeting were approved as presented.
6. **Public Input.** Ms. Arrowood called for public comment and recognized Mr. Gary Chamberlain who spoke to the Board about his anti-litter efforts, involvement by the schools, and acknowledge Mr. Winfield Clonts, Ms. Tiffany Clapsaddle, Mr. Thomas Graham, Ms. Susan Steiner, Mr. Lance Bristol and all the students involved in the school cleanup programs.
7. **Financial Planning Update.** Mr. Winfield Clonts reported several items that were discussed during the subcommittee meeting. Those being:
 - a. Marble elementary school project to include concrete walks and handicap accessibility to the K building and removing of uneven brick pavers.
 - b. Murphy high school bleacher repairs.
 - c. Hiwassee Dam school boiler.
 - d. Andrews high school HVAC repair.
 - e. Murphy middle school HVAC repair.
 - f. District level project—new building project consulting.
 - g. District level VOIP phone system upgrade.
 - h. AMS Baseball field refurbishment project.

Following this, Mr. Clonts reported the subcommittee recommended \$126,882.89 be added to the budget proposal to be presented to the County commissioners for consideration. These funds would be utilized to bring the cafeteria employees up to the state pay standard. He went on to inform the Board of discussions about providing the same to bus drivers in Cherokee County.

8. **Academic Subcommittee Update:** Mr. Tim Coffey was recognized and in lieu of an Academic Subcommittee report proposed the subcommittee hear from principals of schools that did not make growth at a subcommittee meeting during which they will provide reasons why their schools didn't meet growth standards, solutions put in place to correct the problems, rational behind those solutions, and methods being employed to measure success of the corrective actions. Mr. Coffey went on to seek a consensus from the Board that instead of the principals appearing before the Board in March that they provide a narrative containing the aforementioned items to the Board. The Board agreed to this action.
9. **Budget Request.** Ms. Stephanie Hass presented budget amendment request for the following funds:

Motion made (Mr. Paul Brown) and seconded (Mr. Tim Coffey) to approve the budget amendments, usage of ¼ & ½ cent sales taxes, and application for Education Lottery Funds as presented by Ms. Hass. Voting is unanimous.

11. **Superintendent's Report.** Dr. Jeana Conley delivered her Superintendent's report to the Board. She began by presenting a proposed Resolution to the Board that requests the general assembly pass legislation to provide local school districts with the class size and funding flexibility needed to avoid severe negative impacts.
Motion made (Mr. Paul Brown) and seconded (Mr. Winfield Clonts) to adopt the Resolution on K-3 Class Size Ratios as presented by the Superintendent. Voting is unanimous.

RESOLUTION ON K-3 CLASS SIZE RATIOS

WHEREAS, local school districts receive state funding for classroom teacher salaries based on funding ratios of one position per a specified number of students at each grade level; and

WHEREAS, local school districts have traditionally been afforded flexibility to allow class sizes in kindergarten through third grade to exceed the classroom teacher funding ratios within set limits; and

WHEREAS, this approach has provided local school districts with crucial flexibility to fund teaching positions in art, music, and physical education – none of which receive separate funding allotments – by setting aside some teacher allotments to cover salaries for those positions; and

WHEREAS, G.S. 115C-301, as amended by Section 8.33 of the 2016 Budget Bill, codifies funding ratios by statute and precludes these past practices; and

WHEREAS, the loss of flexibility in this area would have immediate and negative effects on school districts throughout the state, including one or more of the following: (i) drastic cuts in art, music, and physical education teaching positions in kindergarten through third grade; (ii) a dramatic increase in class sizes in grades four through twelve to free up state teacher allotments to fund those positions; and/or (iii) sudden new financial burdens on local governments to provide the funding for those same positions, which could necessitate property tax increases; and

WHEREAS, if the issue is not addressed legislatively in the near future, school districts and counties will be forced to develop their 2017-18 budgets in the spring on the assumption and understanding that large increases in local funding may be needed to preserve art, music, and physical education positions in kindergarten through third grade and to meet sudden new demands on school facilities; and

WHEREAS, legislative action is urgently needed to avoid the serious, statewide, negative impacts described above; and

NOW, THEREFORE, BE IT RESOLVED, that the Cherokee County Board of Education respectfully requests that the General Assembly pass legislation as early as possible in the 2017 session to provide local school districts with the class size and funding flexibility needed to avoid the severe negative impacts described above.

Approved by the Cherokee County Board of Education this, the 9th day of February, 2017

Voting is unanimous.


